Under street prepared classifications rules section;

In the sentence "This category is based on stock production vehicles that are easily recognized as such, and must have operational lights, horn, glass, wipers, mirrors, door handles, bumpers, heater and dashboard.", I would like to add the words "bumper reinforcement bars" after the word bumpers.

The reason for this is to not allow someone to just run a bumper fascia with no reinforcement bar thus being excessively lightened.

I would also like to add the following to the street prepared classifications section;

"Doors may not have any structure removed causing them to be excessively lightened – ie; intrusion bar, outer framework and basic structure of the door must remain intact. Basic modifications can be made for purpose of adding safety equipment."

"The floor and trunk area must remain intact and in stock location. Any modifications to the floor or trunk area must be sealed as good as the factory original. All exterior body panels must appear as stock and remain in place (fender flares are free)."

The idea behind this proposal is to make sure a street prepared car is actually a car that can be driven on the street, appears as a streetcar, and is not lightened to the point that it is a prepared car. This is to be added to the present street prepared rules and none of the present rules are to be removed.

General Regulations:

Proposal: Steve Jones

A prepared driver can use an unprepared car or street prepared car (referred to as "replacement car") to accrue points in their class as long as the "replacement car" the entrant is running falls under the safety guidelines for the car the "replacement car". This means; if it is an uncaged car, it must run in accordance to the break out rule for that vehicle. The contestant can use this option one time in a Hillclimb calendar year. The finishing position for the "replacement car" that is used must not exceed the classification rules for the prepared class in which it is being scored.

The reason for this proposal is that under our current rules an unprepared driver or street prepared driver can freely switch cars and remain in the championship where a prepared driver does not have that option. This gives the contestant in the event of a breakdown an option to remain in the championship.

Technical and Safety Requirements:

Remove all mention of Unprepared in 4.E.2.A and 4.E.2.B Add 4.E.2.C All Unprepared cars satisfy the roll cage exemption.
